Summary Frequency Distributions and Percent Calculations for Responses to Questions Asked for the 2018 Oklahoma Highway Safety Office Assessment of the Use of Automated Red-light and Speed Enforcement Systems in Oklahoma

The following tables show the distribution of responses to a quick survey of the identifiable entities throughout Oklahoma that potentially have the authority to utilize automated red-light and speed enforcement systems in their jurisdictions. A list of the entities contacted for this assessment is also included following the response tables.

Overall, throughout February 2018 multiple attempts were made by the University of Oklahoma Public Opinion Learning Laboratory (OU POLL) to contact the 473 entities identified for participation in this assessment. Of those, 461 (97.5%) were screened for use of these systems and 12 (2.5%) could not be reached for comment.

Only in one case did the jurisdiction deploy any type of automated device and it was a speed enforcement camera system rather than a red-light system—the Enid Police Department (Enid PD) currently uses this system and it is owned by the jurisdiction and Enid PD does not follow the operational guidelines put forth by DOT. Considering transparency, Enid PD makes the public aware of the following: placement locations, information regarding revenue and disbursement, the number of citations issued, there is a dispute resolution process in place, traffic data is used both to determine placement of the system as well as to assess the impact of the system on safety, and audits are performed once a month. Enid PD does not have a warning period upon siting the speed enforcement system nor are citations reviewed and signed by a sworn law enforcement officer.
