Executive Summary

Federal Fiscal Year (FFY) 2016 Accomplishments

- American Samoa has successfully achieved "0" fatality in 2016.
- OHS funded DPS Enforcements activities by months are as follow

o Alcohol Enforcement – January

o Speed / Alcohol Enforcement- February to April

o CIOT - Seatbelt Enforcement - May & June

o Speed / Alcohol Enforcement - July

o Speed / Alcohol Enforcement - August & September

o Occupant Protection (OP) - September & November

o Alcohol Enforcement - October & December

• Impaired Driving

o Slight increase of Alcohol impaired driving from ten (10) crashes in 2015 to seventeen (17) crashes in 2016.

Speed

 For the past four years recorded Speed as the least cause of crashes on the highway in American Samoa. Overtime and Regular enforcements continue to deter speed related crashes.

Occupant Protection

o Seat belt usage of 77% in American Samoa for the past five (5) years has always been below the National average. In 2016, with the use of the new survey design approved by NHSTA, we finally achieved 83%, which puts American Samoa at the National level for the first time since the inception of this program.

1.0 Highway Safety in American Samoa

1.1 Introduction

The American Samoa Highway Safety Program is administered by the Department of Public Safety, Office of Highway Safety. The Commissioner of Public Safety, Save Liuato A. Tuitele is the Governor's Representative, and Ms. Sinatoga L. Moliga is the Territory Highway Safety Coordinator.

Mission

The mission of the American Samoa Office of Highway Safety is to reduce the traffic crashes, traffic fatalities, injuries, and property damage on the American Samoa roadways, and to create a safer environment for motorists, passengers, and pedestrians.

Goals

Goals for this Federal Fiscal Year 2016 Annual Report are set and committed to in the 2016 Highway Safety Plan.

1.2 Crash Summary

In American Samoa, the total number of crashes decreased by an average of **50** between 2011 and 2016. Table 1 provides detail in key areas of the American Samoa highway safety trends from 2011 to 2016.

1.3 Program Focus Areas/Challenges

The Highway Safety Office and the Department of Public Safety, Traffic Division continued to make significant progress.

The following program areas were focused on in the OHS' FFY 2016 Highway Safety Plan, page 1. These included:

- 1. **Occupant Protection** Compliant rate for seat belt usage and child passenger safety restraints used in American Samoa has significantly increased from an average of 77% from 2011 to 2015 to 83% in 2016 reaching the national level for the first time.
- 2. **Alcohol** Impaired driving has increased with drugged driving been identified as a problem
- 3. **Speed** From 2011-2015, speed citations with an average of over 1400 issued during grant funded enforcement activities has decreased tremendously in 2016. Increased public awareness and education has played a major role and a contributing factor to this success.
- 4. **Traffic Records** Continue on improving timeliness, accuracy, completeness, uniformity, compatibility, and integration of traffic records for problem identification and performance measurement.
- 5. **Planning and Administration** The coordination, monitoring, and evaluation of highway safety projects.

Table 2 shows the goals of OHS for mitigating these problems in American Samoa.




Figure 1. Number of crashes decreased. Baseline (2011)




Figure 2. Number of Fatalities




Figure 3. Number of serious injuries




Figure 4. Number of Pedestrian Fatalities




Figure 5. Number of Persons Injured




Figure 6. Alcohol Related Crashes




Figure 7. Number of Impaired Driving Arrests




Figure 8. Observed Seatbelt Usag




Figure 9. Number of Seatbelt Citations Issued (2011-2013 was not observed)




Figure 10. Number of Speed Citations Issued
