NEVADA OFFICE OF TRAFFIC SAFETY (OTS)

Mission

The mission of the Nevada Office of Traffic Safety is to eliminate deaths and injuries on Nevada's roadways, so everyone arrives home safely.

Program Funding

Designated by the Governor, the Nevada Department of Public Safety (DPS) is responsible for applying for and administering federal highway safety funds awarded to the State to conduct traffic safety programs that positively affect driving behavior. The Director of the Department serves as the Governor's Representative for Highway Safety and has designated the Administrator of the Office of Traffic Safety as the Highway Safety Coordinator. To accomplish this task, the Department of Public Safety, Office of Traffic Safety (DPS-OTS), develops an annual Highway Safety Plan (HSP) that identifies critical highway safety issues and problem areas in the State. DPS-OTS then solicits proposals statewide to address the identified problems. Available funds are awarded to state and local government and non-profit agencies to implement evidence-based traffic safety programs and projects. Programs are also supported using State funds, grants received from private organizations, and FHWA funds passed through from Nevada Department of Transportation, as allowable.

This report summarizes the activities of the FFY 2021 Highway Safety Plan and serves as Nevada OTS' Annual Report.

DPS-OTS annually awards federal funds to state, local, and non-profit organizations desiring to partner in solving identified traffic safety problems. Funds awarded are strictly for use in reducing deaths and serious injuries caused by motor vehicle crashes through the implementation of programs or strategies that address driver behavior in the priority problem areas. These program areas, in alignment with the Strategic Highway Safety Plan (SHSP), are:

- Impaired Driving
- Occupant Protection (seat belts and child safety seats)
- Pedestrian Safety
- Traffic Records
- Distracted Driving
- Youth Driving
- Speed
- Motorcycle Safety
- Bicycle Safety

Grant funded activities in the FFY2021 cycle continued to be somewhat impacted by restrictions and issues related to the Covid-19 pandemic, even as traffic crashes and risky behaviors increased in Nevada.

Performance Measures

Rules established by NHTSA guide states to identify problems and funding needs in each of the nationally designated program priority areas. State Highway Safety Offices (SHSOs) have the flexibility to identify additional program areas from their data, along with the amount of funding allocated to each. Nevada utilizes this flexibility in working with its SHSP partners toward achieving its goal of 'Zero Fatalities.' The projects chosen for funding in FFY 2021 included strategies from the SHSP's seven critical emphasis areas, and their results are detailed on the following pages. 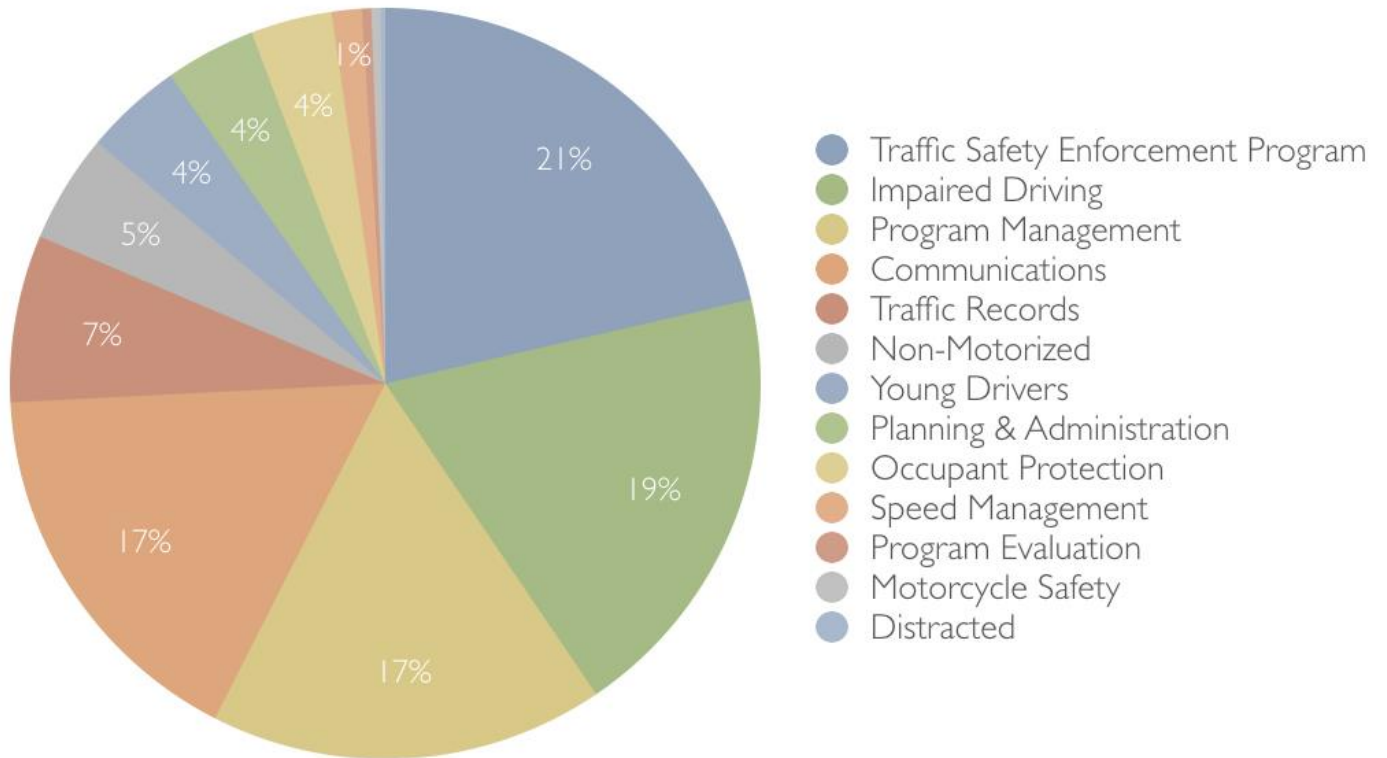
PERFORMANCE MEASURE TARGETS, PROJECTIONS AND PLANNING

The following table summarizes the agency's assessment of likely 2021 achievement of performance targets. Preliminary 2021 year-end data provided by the state's FARS Analyst will be calculated in January of 2022 and will be used to inform the 2023 Highway Safety Planning process. Nevada sets its performance targets based on five year trends and incorporates data that reflects growing, decreasing, or maintaining traffic safety trends into the Highway Safety Plan accordingly. Adjustments to the 2023 HSP to address overall continued improvement, and improvement in meeting unrealized performance targets will be based on key crash factors, and those that represent a high percentage of fatalities, including impairment and non-motorized road users. The Office of Traffic Safety will continue to increase funding and identify projects in both education and enforcement to reduce distracted driving related crashes.

One performance target, Serious Injury Crashes, was not met. The discrepancy between the target and the final result is slight and no specific adjustments are planned.

Nevada has a robust traffic safety enforcement program across multiple law enforcement agencies that conduct specific enforcement events covering all of Nevada's Critical Emphasis Areas (Impaired Driving, Occupant Protection, Speed, Distracted Driving, Pedestrian Safety, and Motorcycle Riders). Of the approximately 50 law enforcement agencies statewide, including school districts, tribal law enforcement, state patrol, and local police and sheriff departments, 26 agencies participated in the coordinated high visibility enforcement events, including one Tribal agency, covering 98% of the state's public roadways. Enforcement activities were significantly impacted in FY2020 due to multiple pandemic related issues, shutdowns, workplace and staffing disruptions, etc. During the 16 events in FY21 53,417 traffic enforcement stops/contacts were made for a variety of violations, following is the breakdown of citations written:

NDOT and the Nevada Office of Traffic Safety (OTS) continue to partner on the Zero Fatalities Nevada efforts. This includes a greater coordination with a single advertising firm. Duplication of efforts has been reduced with public relations, paid media and outreach is implemented by a single source. In FFY 2021, OTS ran six media campaigns, which included both paid and earned media components. Overall, from October 2020 – September 2021, the OTS Zero Fatalities-branded campaigns delivered over 218 million impressions. The Zero Fatalities program continues to have a recognition of over 43% with Nevada residents.

The Office of Traffic Safety (OTS) develops statewide projects in cooperation with other state, local, and non-profit agencies that partner on the State Highway Safety Plan. Local strategies and projects are developed by working with those agencies that have expressed an interest in implementing an evidence-based traffic safety project in their community. OTS provides outreach and educational materials to the public and partnering agencies while providing training, extending traffic safety messaging and improving reception of appropriate behaviors and actions.

This project was a resource for the Office of Traffic Safety staff and Nevada traffic safety partners to attend or participate in conferences, training, courses, or similar events that further enhance their knowledge and skills to combat traffic fatalities and serious injuries. This project aims to provide continuing educational opportunities for OTS staff as well as its safety advocate partners to further combat motor vehicle fatalities and serious injuries on Nevada roadways. Very little activity occurred on this project due to the Covid pandemic restrictions on travel and cancellation of in-person training and conferences.

This project funds the Highway Safety Plan (HSP), which describes data analysis of Nevada traffic safety issues and the strategies which will be used to address those issues in partnership with the State Highway Safety Plan (SHSP), and the Annual Report provides information on the implementation, outcomes and evaluations of the funded projects.

This project provides funding in partnership with the Nevada Department of Transportation (NDOT) to host the annual Nevada Traffic Safety Summit. The 2020 Traffic Safety Summit was held in October in Southern Nevada and included two and half days of speakers, workshops, breakout sessions, a motorcycle forum, and vendor demonstrations. Attendees of the Summit included private and public agencies, the public, sub-recipients, tribal representatives, local law enforcement and regional transportation commissions, Nevada Strategic Highway Safety Plan (SHSP) partners.

TS-2021-LVMUNI-00062- Las Vegas Municipal Court – Traffic Court Compliance**Funding Sources: 402****Award Budget: \$30,000.00****Obligation Spent: \$16,012.50**

The goal is to improve traffic safety in Southern Nevada by providing individualized case management services to long-term non-compliant individuals so that they can learn safe driving habits and resume legal driving. Progress: The Las Vegas Municipal Court did hire a part time Case Manager for the Safe Traffic Incentives Program (STIP), in accordance with the grant timeline, and has decided to continue her employment beyond the grant period. 80% of those individuals participating in the court ordered program will have their driving privileges restored in 9 months.

The Below 100 trainer on OTS staff has reviewed and completed modifications to the basic curriculum to expand

Obligation Spent: \$12,490.00

Nevada Operation Lifesaver (NVOL) conducted community safety outreach through media and presentations throughout the State. NVOL was able to conduct 10 active awareness events at rail crossings. The media outreach was done through radio and Facebook and was determined to reach approximately 2500 people and approximately 6000 impressions. NVOL was able to education through community outreach at roughly 15 different events held. Law enforcement training was submitted to Churchill County Sheriff, Pershing County Sheriff and POST training. NVOL was able to complete all the projected objectives it set. They were also able to have the Nevada DMV Driver's handbook updated.

TS-2019-UNLV-00149- University of Nevada, Las Vegas-Evaluation of Nevada Traffic Safety Prevention Programs

This project funds researchers within the Department of Surgery at the University of Nevada, Las Vegas School of Medicine (UNLV SOM) to help evaluate existing traffic safety prevention programs within the state and make best practice recommendations to provide programs with a means to evaluate their program critically. Two projects were accomplished within the year.

The first project was to complete and deliver final reports for the DUI Toxicology research project. This project included data cleaning, preparation and merging data across three labs. Significant progress was made and will continue into FFY22.

The second project was a pilot project to assess the evaluability of two traffic safety projects with the Injury Prevention Evaluation Toolkit. Three hospital-based Child Passenger Safety programs were selected. The project was successful in evaluating the toolkit and is determined viable for other NV OTS traffic safety programs.

Conducted all the necessary pre data collection activities. Conducted the pre-mobilization and post-mobilization observational seatbelt surveys, analyzed the results, compiled the draft and final report. Submitted the final FFY 2021 Observational Seat Belt Survey to OTS.

Created the survey questionnaire in consultation with OTS, developed application to deploy survey with portable digital device, define regions of state to be surveyed, designed statistical framework of survey, analyzed the results, compiled the draft and final report. Submitted the final FFY 2021 Attitudinal Seat Belt & Child Passenger Safety Seat Attitudinal Survey to OTS.

PERFORMANCE MEASURE 5: FATALITIES INVOLVING A DRIVER OR RIDER WITH A BAC OF .08 OR ABOVE

TS-2021-LVMuni-00051 DUI Court Case Management

Funding Sources: 405(d)

Award Budget: \$19,500.00

Obligation Spent: \$5,745.00

This project funded the court to hire a part-time bi-lingual DUI Court Case Manager to their participants who are 38% Hispanic. The bi-lingual DUI Court Case Manager was not hired until June, eight months into the grant cycle. The Project Director related that the delay in implementation was partly due to finding a qualified candidate and partly slowed by larger court problems. Municipal Court operations were suspended due to Covid lockdowns several times during the year, each closure lasting more than a month.

There were 4 claims submitted for June through September; those that were submitted were timely and accurate. The funded DUI Case Manager was on contract and therefore payroll certification reports were not required. In-kind contributions were higher than the grant expenditures: \$8,325.07

The DUI program was conducted, as described in the Activities section of the grant proposal, in accordance with the Adult Drug Court 10 Key Components. During the grant period, 29 new participants were admitted to the DUI program. 13 previously admitted participants graduated, and 15 participants were terminated for non-compliance. The court team met weekly throughout the year, and spent an average of 30 minutes a month reviewing ignition interlock reports for the several individuals required

to have the device. In a normal year without Covid-19, the expected number of new participants is 30. During this year, with the repeated interruptions in service, 29 new defendants entered the DUI Court program.

According to the Court-maintained drug testing logs, in-program drug use was reduced by 93%. The objective to increase the graduate rate to 66% failed to be measured. The historic rate of recidivism for this program is 15%.

TS-2021-WC DA-00194 Traffic Safety Resource Prosecutor

Obligation Spent: \$216,387.98

This project funded the Washoe County District Attorney's Office for the position of Nevada Traffic Safety Resource Prosecutor (TSRP) for purposes of reducing impaired driving in Nevada. The TSRP educates and trains prosecutors, law enforcement, judges, probation staff, and legislators on topics crucial to impaired driving/traffic safety and provides experienced litigation assistance in the courtroom.

The 2021 Nevada Prosecutors Conference was forced into a virtual setting this year because of fire emergencies in the Lake Tahoe area, but it appears the online venue may have permitted more prosecutors to attend. The "Nevada TSRP" YouTube Channel has continued to grow and now hosts 7 training videos for law enforcement. A new website development is underway that will be devoted to providing online resources to law enforcement and prosecutors. He works to increase his technical knowledge of impaired driving matters, as well as public outreach. He has become a DRE Instructor and plans to continue to teach at DRE schools to increase our DRE numbers to support a DRE Callout program to be completed in Southern Nevada and eventually in Northern and Eastern Nevada. Additionally, he continues to advocate for mandatory ARIDE training for all peace officers in Nevada and take advantage of teaching opportunities when feasible. The TSRP works regularly with stakeholders across Nevada and uses his position to pursue NHTSA public awareness and legislative goals.

TS-2021-NVOTS 658-00024 -Nevada Office of Traffic Safety- DUI Training for Courts/Judges/Prosecutors**Funding Source: 405(d)****Budget: \$30,000.00****Obligation Spent: \$10,709.30**

This project funds courts in Nevada by providing encouragement and assistance to attend training through the National Center for DWI Courts (NCDC). The in-person training was aimed at providing DUI Court teams including the judge and case manager foundational skills to assess their participants correctly and implement best practices to achieve a good outcome. They also offer Court Technical Assistance to provide DWI Courts to implement improved program practices.

TS-2021-Judicial-00192 Judicial Outreach Liaison**Funding Sources: 402****Award Budget: \$45,337.00****Obligation Spent: \$24,991.30**

This project funded outreach to thirteen tribal courts in Nevada to determine whether these courts are functioning well with their traffic dockets and to provide guidance on resources, subject-matter, or skills-based training as needed.

This was the first year for this program and perceptions changed once the activities got underway. The Request for Funding was not submitted until December and the first claim was not submitted until February. There were periods of little or no activity, offset by valuable productivity. Two of three goals were achieved even though travel and community restrictions resulting from the Covid pandemic made it impossible to make as many site visits to tribal courts as planned. Because only one tribe completed and returned the tribal court DUI inventories, the Tribal JOD was not able to develop a more complete and definitive Work Plan to include appropriate objectives and activities stated in the NHTSA document "Best Practices for Implementing State Judicial Outreach Liaisons". Outreach efforts resulted in providing tribal court judges with information about the outreach program and the ABA JOL resources available to them.

TS-2021-CC District Court-00056 Carson City District Court**Funding Sources: 405(d)****Award Budget: \$22,250.00****Obligation Spent: \$22,250.00**

This grant is to partially fund the DUI Case Manager position in the Carson City Department of Alternative Sentencing (DAS) to lower recidivism of DUI offenders in Carson City.

The program has succeeded in having a full-time lab tech making them able to achieve the goal of a 24-48-hour testing turn-around, enabling the specialty courts to maintain better compliance with the NADCP best practice standards of three tests per week and promptly addressing negative behaviors. The Program served an average of 21 participants. Of those 21 participants, 9 completed successfully, 1 transferred to another jurisdiction and 1 voluntarily withdrew. The year ended with 1 reoffender for the DUI Court program. Since 2017, the DUI program has only had 3 reoffenders of the 27 graduates.

TS-2021-DC-00135 District Court-Clark County**Funding Sources: 405(d)****Award Budget: \$30,000.00****Obligation Spent: \$30,000.00**

This grant partially funded the position of Felony DUI Court Coordinator. The purpose is to target and treat repeat recidivist defendants who drive under the influence of alcohol or a combination of alcohol and other substances. Program Graduates: 67 (66%), down from 112 in 2019. The Program is a 3–5-year program in lieu of a prison sentence. Participants graduated this year began in 2017/2018, when there were approximately 101 new participants. The rest of the participants who didn't successfully graduate were retained for not meeting graduation criteria, terminated for non-compliance or ICE Holds, transferred, or voluntarily left the program. Two participants were unable to successfully complete due to the financial requirements of stricter monitoring or an increase in treatment, which raised their program costs to about \$10,000. Although their sobriety is strongly intact and their thinking patterns have changed significantly, they are still facing the negative impact of their past actions making it more difficult for them to move on with their futures in a positive way.

The project had a delayed start due to Covid-19 restrictions. The project was able to train 21 new DRE's and 50 new ARIDE officers. 105 officers were given refresher training in SFST and ARIDE. 7 DRE's and 2 DRE state coordinators were able to attend the annual DAID conference. These results fall in line with the original project objectives. Due to Covid-19 restrictions the project directors were unable to identify and schedule continuing education training during this grant cycle.

TS-2021-LVJC-00009 Las Vegas Justice Court DUI Court**Funding Sources: 405(d)****Award Budget: \$50,000.00****Obligation Spent: \$50,000.00**

The project partially funds one full time Specialty Courts Coordinator. The purpose of the funding is to reduce repeat incidents of driving under the influence by requiring accountability and providing access to rigorous treatment services. Results were affected by the affect of the pandemic on referral sources as well as on the behaviors of the participants.

Outcomes compared to 2020

-Total active cases increased by 11 but represented almost 30 individuals less than the previous year.

-Retention rate: down 1.6 %

-Use of alcohol and/drugs rate: 2% increase

-Program graduations: down 6

-Program terminations: increased by 2

-Incarceration imposed rate: increased by 1%

-Recidivism rate: down to 0.5% from the previous year of 1.7%.

Highlighted successes: Many participants relapsed over Labor Day weekend, but when the treatment team increased the frequency of drug testing, they responded well to the interventions. Every participant got back on track.

The 2021 Traffic Safety, driving under the influence (DUI) mobile processing grant helped to assist the Las Vegas Metropolitan Police Department (LVMPD) officers in the field when DUI suspects are identified and contacted. Additionally, the DUI vans/patrol vehicles were used for special events, sobriety checkpoints and various community events related to DUI prevention and education. This is the first year we began keeping stats on van activities. It was believed that most reported data would be duplicative, but between Sgt. Stoddard and myself, we were able to develop a stat sheet that shows how useful the van is in support of DUI patrols through collecting such data as the number of times the van was fielded, the number of assists and transports, and the number of blood draws attained.

From October 1, 2020, to September 30, 2021:

- DUI mobile processing vehicles were deployed on at least 171 occasions, an increase of 29 deployments from previous year. Officers staffing the vehicles assisted other officers from LVMPD and other jurisdictions as well as conducting enforcement on their own. The DUI Mobile Processing Unit was used at each of the 14 DUI Blitz events, and to all "Every 15 Minutes" events where they interacted with kids and families and talked about the dangers of driving impaired. Community events were limited due to Covid restrictions.
- Officers and phlebotomists assisted in the arrest of 703 impaired drivers, an increase of 298 arrests from the previous year. This assistance included administering evidentiary breath testing, conducting blood draws, transporting impaired drivers to different jail facilities, and obtaining search warrants for impaired drivers who refused to voluntarily submit to evidentiary testing. Officers also issued citations for collision causing violations during proactive enforcement.

All the goals and objectives were met or exceeded. Officers working this event supported DUI saturation/enforcement officers, utilized the Intoxilyzer for impaired drivers, transported offenders, authored search warrants for evidentiary testing, and conducted proactive enforcement. The vans assisted officers from other local law enforcement agencies including Henderson PD, North Las Vegas PD, Clark County School District PD, Nevada Fish and Wildlife, and Nevada Highway Patrol. The DUI van was utilized at DUI saturation enforcement events along with an on-site phlebotomist. The vans were also used for community events and high-profile events including NASCAR and New Year's Eve.

TS-2021-WC 2nd Jud Ct-00181 Washoe County Felony DUI Court**Funding Sources: 405(d)****Award Budget: \$30,000.00****Obligation Spent: \$30,000.00**

Court closures due to Covid were an ongoing challenge and resulted in a drastic reduction in referrals to the program. The FDUI Court program continued to experience successes this past year despite the obstacles. Success was achieved by adhering to their mission to protect public safety and pursuing set goals, which were to focus on meeting statutory requirements, continuing education and training for team members, updating program policies and procedures, and maintaining tracking methodology to capture data for reports and program analysis.

Success was measured by a reduction in substance use among participants, tracked by monitoring positive drug screens, which on average are in the high 97 percentile. In 2019 the Court joined forces with the Washoe County Department of Alternative Sentencing (WCDAS) resulting in a new agreement to lower the cost of drug screens and allowing the Court to require additional drug screens for the participants.

Another success of the FDUI Court was maintaining zero percent DUI recidivism on DUI-related offenses. This

program is the only DUI Court that has been able to report accurate recidivism data. The Court was ahead of the curve when developing a structure of MOUs where a statistician can pull data from the Drug Court Case Management System (DCCM) and the Repository to track recidivism of their graduates for three years following completion of the course.

Agency performed minimally due to pandemic, staffing, and wildfires and was not funded in 2022.

This project funded overtime for DUI enforcement in the City of Las Vegas and Clark County. Efforts were concentrated during weekends and special events to combat the high number of DUI related incidents and crashes that occurred. LVMPD has a full-time DUI Strike Force which was leveraged by the additional overtime hours funded through this grant. There were at least 60 deployments and 2,040 overtime hours reported. The enforcement teams worked in conjunction with the Las Vegas Metropolitan Police Department DUI van as well as with the DUI Strike Team. Reported stats related to this funding were as follows: 60 DUI crashes; 376 DUI arrests; 747 SFSTs conducted; 97 refusals; and 2554 stops. On average it took approximately 7 stops to make 1 arrest, and the cost per DUI was \$396.88.

All goals and objectives were exceeded:

- DUI arrests increased approximately 41%: from 267 in 2020 to 376 2021.
- Overtime hours were increased approximately 57% over last year.
- Enforcement patrols increased 56%: from 65 in 2020 to 102 in 2021.
- Number of SFSTs conducted rose by 81%
- DUI related fatalities were 51% below the objective and 53% lower than 2019. This objective was met against all odds. While COVID lockdowns pushed the national rate upward, the LVMPD jurisdiction saw 21 fatalities during this grant period

This project was to fund overtime for DUI enforcement statewide and equip approximately 220 Department of Public Safety (DPS) officers with preliminary breath testing devices (PBTs) to effectively identify and prosecute impaired drivers. A purchase of PBTs was made for \$89,749. There were 2133.42 overtime hours used; and 305 arrests, 141 SFSTs conducted; 2122 stops; 20 refusals; and 13 impaired crashes. On average, it took 7 stops to result in arrest, at a cost of \$377.91 per DUI.

Statewide, NHP handled approximately 1,427 cashes involving an impaired driver; a 23% increase over the previous year. DUI fatalities rose by 69%. Arrests increased by 17% over the previous year, but the number of SFSTs decreased by -13%.

This was a challenging year with Covid restrictions and the subsequent effects on both staffing and the civilian population; the civil unrests during the year forcing NHP to deploy available personnel to safeguard government buildings, communities, and businesses; and the California fire season causing prolonged unhealthy air conditions.

TS-2021-RPD-00107 RPD Preventing Impaired Driving through Education and Enforcement**Funding Sources: 164****Award Budget: \$40,000.00****Obligation Spent: \$38,827.08**

Reported stats were as follows: 575 overtime hours; 55 arrests; 514 stops; 94 SFSTs conducted; 21 refusals and 5 impaired crashes. The average number of stops to an arrest were 9, and the cost per DUI was \$687.77. RPD also reported 173 violations and 308 warnings, suggesting that either the focus was not 100% on DUIs or that there weren't that many drivers under the influence in Reno.

Early operations were difficult to staff as officers were out on Covid leave and/or had personal time conflicts. Covid social distancing measures together with reduced tourism and casino activity contributed to the decline in overall DUI arrests, while the program reported observing increased substance abuse due to the stressors associated with the pandemic. RPD tracks the average BAC levels during stops, and reported average tests were .169. Stops decreased by 8; SFSTs decreased by 13; refusals increased by 9; and crashes decreased by 3. The grant-funded arrests, however, remained about level with the previous year, while the combined DUI arrests for the entire RPS declined 5.19%.

The University Police Services officers patrol southern Nevada campuses 24-hours-a-day, seven days a week, 365 days a year. All officers are now trained in the use of PBTs and impaired driver investigations. The purchase of 12 PBTs was made in December 2019, and by January 20, 2020 all 12 of the PBTs were calibrated by LVMPD Lab and 80% of the Campus Police officers had been trained on device usage. Two PBTs were deployed to each substation: UNLV, WCC, HND, NLV, NSC, and sign out sheets were posted with the PBTs. All PBTs were checked for accuracy monthly. The training coordinator put a plan in place for training to ensure officers were familiar with the equipment prior to the first Joining Forces Impaired Driving event in February. A total of six Joining Forces events were completed during the year. The department worked on addressing the issue of PBT use during the Covid pandemic. The tracking sheet submitted with the Final Summary Report, however, showed the PBTs were only used 13 times over the year, leading to 10 arrests.

The project was intended to reduce the number and severity of crashes in White Pine County while increasing the number of DUI arrests.

From 10/01/2020 to 09/30/2021 WPSO reported 249 crashes and 51 DUI arrests.

The weekend saturation patrols resulted in an approximate 16 % (16.66%) increase in impaired driving arrests during the same period the previous year. From November 2019 through October 2020 the Sheriff's Office combined to make 126 impaired driving arrests on Friday and Saturday nights. During the same period November 2020 thru September 2021 the Sheriff's Office made 147 Impaired driving arrests. The deputies working impaired driving saturation patrol provided by this grant award made 18 of the 147 arrests. Unfortunately we did observe an increase in Friday and Saturday night DUI related crashes in comparison from 21 in grant period 2020 to 26 in grant period 2021.

The Washoe County Sheriff's Office completed ARIDE training for 17 officers during the grant award period. The Sheriff's Office has instituted the ARIDE training in the patrol transfer academy so all newly assigned patrol deputies will have the training. The Patrol division has 98 Deputies and Sergeants assigned and 85 % of our division has completed the ARIDE training. The Deputies assigned to patrol were all provided with informational training in regards to NRS Chapter 484 and the requirements for ignition interlock laws for some offenders.

Zero Teen Fatalities increases awareness of the impact of seatbelt usage and the dangers of impaired and distracted driving, as well as speeding and aggressive driving, which are all critical safety issues for this 15-20-year-old age group. The program is a fast-paced and always evolving program that has found success and continues to expand. As can be expected, the program substantially decreased its in-person presentations due to the Covid pandemic and shut down of schools and activities. Information was provided to 380 teens on safe driving via 12 statewide high school presentations, 12 outreach events, partnering events with new stakeholders. Following March 2020 the focus of the program shifted to providing information and education via digital and online training deliver. This will continue throughout the various programs which has proven to allow ZtF to expand its reach into more rural communities. The program has enhanced processes and evaluation with the use of technology by utilizing a Wufoo online program while driving programs such as Driver's Edge, D.R.I.V.E., Moto 101, and Code Zero have gone paperless for their pre/posttests and evaluations. The Driving Responsibly Includes Vehicle Education (D.R.I.V.E.) court-appointed juvenile program, was expanded to Reno, Carson City, Henderson, and three rural areas: Winnemucca, Elko, and Pahrump.

From October 1, 2020, to September 30, 2021, LVMPD's Pedestrian Safety enforcement teams were deployed on at least 88 occasions. The Pedestrian Safety enforcement resulted in at least 5,099 violations issued to pedestrians for violating pedestrian traffic safety laws and to vehicle drivers for violating traffic safety laws. Officers arrested 6 impaired drivers. 10 felony arrests were made, and another 6 misdemeanor arrests were also made. Over 760 hours of non-grant funded (in-kind funds) were spent by LVMPD to staff Pedestrian Safety enforcement. This enforcement, combined with grant funds, resulted in over 2,116 hours of LVMPD Traffic officers on Las Vegas roadways enforcing Pedestrian Safety statutes.

Activities occur statewide with the primary focus being the Las Vegas Metro area, where high speed limits, wide streets, and heavy pedestrian and motorized traffic contribute to high crash fatality rates.

A press release was also completed and a video released on the agency's social media regarding school zone safety.

The goal set by RPD was a 4% reduction. Non-motorist fatalities were reduced by 66.7% also well over the 4% goal. RPD was not able to attend as many school visits due to COVID obstacles.

729 citations were issued for speeding, 8 for distracted driving, and 5 for either drivers or pedestrians failing to yield the right of way. Additionally, 134 warnings were issued to educate drivers and pedestrians on school zone safety.

The Washoe County School District Police Department purchased 15 radar devices to use in and around school zones to reduce speeding. Some months there was no activity because schools transitioned to a distance learning model because of Covid-19. An example of the increased activity with the use of the radar devices is illustrated during the months of May through September. In 2020, 107 citations were issued. In 2021, 193 citations were issued, an 80% increase.

- Public relations (media interviews and press releases)

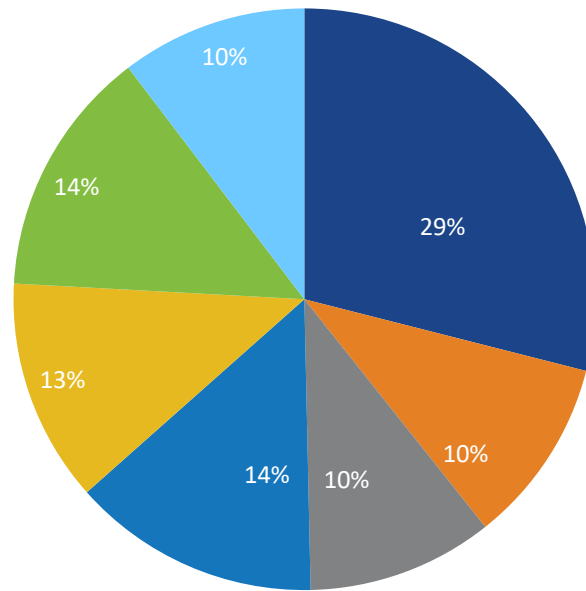
Campaigns
