Measurement Method

This measurement is based upon the average number of days from the crash occurrence to the date the crash report is entered into the State of Hawaii Advanced Crash Analysis (SHACA) database, HDOT's crash reporting database.

In Hawaii, there are four counties within the state – Hawaii County; the City and County of Honolulu; Maui County and Kauai County. Each county has its own police department that generates and collects the crash reports for their respective counties. HDOT receives the crash reports from these four county police departments – HPD, HCPD, MPD and KPD.

HDOT and the four county police departments have been working to streamline processes and improve upon timeliness of crash data. The police departments' migration to electronic crash reports and HDOT's new SHACA crash reporting database have contributed significantly to improvements in receiving crash reports in a timely manner and entry into the database.

We arrived at our baseline by querying the SHACA data system for crashes that occurred within the baseline period and used programming to obtain the data entry date for the crash reports, the number of days from crash occurrence to data entry, and the average of those days.

To determine measurable progress, we repeated this process for the performance period.

Measure Description

Hawaii improved upon timeliness in our "Crash" core data system as measured in terms of a decrease in the average number of days from the crash date to the date the crash report is entered into HDOT's crash reporting database, for all counties.

Measurable Progress Report


From May 1, 2022, through April 30, 2023, it took an average of 11 days for all counties from crash occurrence to entry into the crash reporting database. From May 1, 2023, through April 30, 2024, the average number of days from crash occurrence to entry into SHACA decreased to 9 days, an improvement upon timeliness with our crash reporting database.
